MEMORANDUM OF ASSOCIATION OF

CVR FOUNDATION

1. **Name of the Society:**

The name of the Society shall be "CVR FOUNDATION".

2. **Registered Office:**

The Registered Office of the Society shall be at Door No.48-9-17, Dwaraka Nagar, Viskhapatnam, 530016.

3. **Aims and Objects:**

The aims and objects of "CVR FOUNDATION"

Shall be -

1. to undertake Rural Rehabilitation Schemes including construction of houses , colonies with necessary infrastructure, education and medical facilities to the poor and deserving especially fishermen in and around ports, *without any profit motive.*
2. to promote activities for total development, namely, Social, Economic, Educational, Medical Relief and Cultural fields in the rural areas with a particular emphasis on downtrodden, economically weaker sections and people below the poverty line.
3. to establish, maintain, run, develop, improve and extend educational institutions including vocational training centers and similar other institutions.
4. to provide and carry on classes for propagation of adult education, to takeover any existing educational institution/institutions or vocational training centre/ centers and to conduct, maintain, run, develop and improve the same subject to the regulations of the Government in this behalf.
5. to assist and guide educated unemployed in seeking employment with a particular emphasis on rural youth.
6. to establish hospitals, nursing homes, clinics, surgical theaters, health units, etc., and provide medical facilities to the public.
7. to construct houses in the rural areas for downtrodden, economically weaker sections and people below the poverty line, *without any profit motive.*
8. to establish, maintain and grant aid to homes, orphanages or other establishments for relief and help to the poor and needy, without any reference to Caste or Creed to which one belongs.

9. to make an endeavor to provide the possible relief during natural calamities, such as famine, earth-quake, flood, fire, pestilence and other occasion of similar nature by methods such as giving donations, subscriptions or contributions to institutions, establishments or persons affected in such calamities, etc.
10. to establish community halls for fostering social contracts and serving the social needs of the public at large.
11. to provide for Educational and Research in the fields of science, technology, humanities, Industries, Business management and Public Administration and to disseminate such experimental and innovative ideas, knowledge and techniques as are necessary to promote industrial, Economic and Social Advancement of the Country.
12. to establish such types of Institutions of formal, non-formal and continuing Education at such places as are suitable for the dissemination of such knowledge pure and applied with the requisite facilities there of such as staff, libraries, laboratories etc.
13. to be a centre for Research in academic, administration, educational , meteorology s with a view to contributing to the improvements in the systems and methods thereof.
14. to promote integration and dissemination of knowledge in various fields of human activities related to academic, educational, social, managerial, administrative and research fields etc.
15. to undertake research, organizational and development programmes on contract with Government, Quasi-Government local bodies, public or private agencies.
16. to promote self confidence and spirit or self-reliance among youth, to enable them to acquire necessary skills and guide them to achieve excellence in their fields of activity.
17. to train or arrange to train and guide prospective candidates for various competitive examinations conducted by the National, International, Regional, State Government, Quasi-Government, Public and Private Institutions, local bodies, agencies, service commissions for the purpose of appointment or for administration into academic and professional courses and studies etc.

18. to promote national integration and unity of the country.
19. to provide scholarships/fellowships and render financial assistance including by provision of loan to the deserving candidates.
20. to publish books, newspapers, journals, brochures, pamphlets, etc. for the purpose of achievement of the objects of the Society.
21. to provide boarding and lodging facilities to students and working youth.
22. to honour and encourage outstanding, distinguished and deserving persons in public life, social service, music, art and literature, etc.
23. to establish, run, develop, maintain improve and extend grants donations for an to aid and assist for the establishment, maintenance, development, running improving and extension of any other types of public charitable institutions having same or similar objects.
24. to recognize, affiliate, associate, participate and \ or merge, either in India or abroad, with institutions having similar objectives which express their willingness to co-operate with it or co-ordinate their activities with those of this Society.
25. to do all such other deeds and things either alone or in conjunction with others are incidental or conductive to the attainment of the objects stated herein or any of them.
26. to enter into any agreement or arrangement with any other Society, foundation or any other party having any legal entity or any individual for the purposes of the Society .
